ORDER APPROVING EXCEPTIONAL BENEFITS

Comes now the Board of Directors of the South-West Lake Maxinkuckee Conservancy District by counsel, Alan M. Hux, for a hearing on the Report of Appraisers previously filed with this Court on October 24, 2011. The Board of Directors of the South-West Lake Maxinkuckee Conservancy District filed its exceptions to the Report of Appraisers, no freeholders filed exceptions to the Report. After hearing the evidence, reviewing the Report of Appraisers and the Exception to the Report filed by the Board, and the Court being fully advised in the premises now finds as follows, to-wit:

1. The Board of Appraisers of the South-West Lake Maxinkuckee Conservancy District duly appointed by this Court filed its Report of Exceptional Benefits with this Court on October 24, 2011 as required by I.C. 14-33-8 et. seq.
2. Due Notice of the hearing on the Report of Appraisers was given pursuant to I.C. 14-33-8-12 by publication in the *Plymouth Pilot* on October 26, 2011 which was a day at least thirty days before the date of this hearing. All pursuant to the proof of publication filed herein.
3. Notice of this hearing was mailed to all freeholders owning land named in the report according to the records of the auditor of Marshall County by mail, first class, postage prepaid, on November 3, 2011 which is a day at least twenty days before the date of this hearing as required by I.C. 14-33-8-12(8)(2).
4. The South-West Lake Maxinkuckee Conservancy District was mailed notice of hearing on the Report of the Board of Appraisers hearing to the at least twenty days before the

date of this hearing, by first class, postage prepaid pursuant to I.C. 14-33-8-12(8)(3).

5. The Report of Appraisers conforms to the requirements of I.C. 14-33-8-10.
6. The Board of Director's of the South-West Lake Maxinkuckee Conservancy District timely filed exceptions to the Report of Appraisers requesting that the exceptional benefit for all lots in the District except for Tract numbers 32, 37, 55, 65, 82, 104, 118, 121 and 124 as set forth on Exhibit "A" be Seven Thousand Five Hundred Dollars (\$7,500.00) and for Tract numbers 32, 82, 118, and 121, as set forth on Exhibit "A, " the exceptional benefit be Fifteen Thousand Dollars (\$15,000.00) since there are two (2) connections for each of said freeholds and that Tract numbers 37, 55, 65, 104, 124 on Exhibit "A" should not be assessed any exceptional benefit.

7. The Court has received no other Exceptions to the Report of Appraisers filed by any freeholder who owns land in the District or any other person.

8. The Board of Appraisers has complied with requirements of I.C. 14-33-8-1 et. seq.

9. The Report of Appraisers should be amended to confirm with the Exceptions filed by the South-West Lake Maxinkuckee Conservancy District and the evidence presented at this hearing.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

(1) The Report of Appraisers filed in this cause entitled Summary Report of a Restricted Appraisal Analysis from the Board of Appraisers concerning the South-West Lake Maxinkuckee Conservancy District New Forced Main Sewage Line is hereby amended to conform with the evidence presented in this cause;


(2) The Exceptional Benefit for all lots in the District except for Tract numbers 32, 37, 55, 65, 82, 104, 118, 121, and 124 as set forth on Exhibit "A" shall be assessed at Seven Thousand Five Hundred Dollars (\$7,500.00);

(3) The Exceptional Benefit for Tract numbers 32, 82, 118, and 121, as set forth on Exhibit "A," shall be assessed at Fifteen Thousand Dollars (\$15,000.00) since there are two (2) connections for each of said freeholds;

(4) The Exceptional Benefit for Tract number 37, 55, 65, 104 and 124 on Exhibit "A" shall be assessed at Zero Dollars (\$0.00); and

(5) The Report of Appraisers as amended is hereby approved.

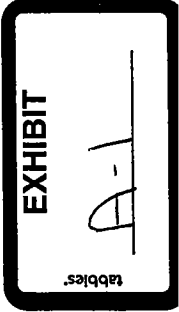

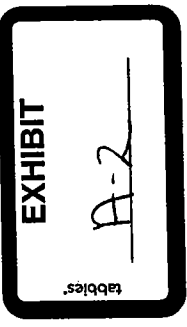
