"INVITATION FOR NOMINATION TO FILL UPCOMING VACANCIES ON THE BOARD OF DIRECTORS OF SOUTH-WEST LAKE MAXINKUCKEE CONSERVANCY DISTRICT.

The Board of Directors of the South-West Lake Maxinkuckee Conservancy District hereby invites nominations to fill the upcoming vacancies on the Board of Directors created by the expiring terms of Jim Purucker, Director of Area 5, and John Crist, Area 7, and the unfilled seat of Area 1. All Directors elected at the 2025 Annual Meeting will serve until the District's 2029 Annual Meeting. The Areas are described as follows:

thence southeast 190 feet more or less along the west boundaries of lots 750, 740 and 730; thence south along the west right-of-way of West Shore Drive 130 feet more or less; thence northwest 30 feet more or less along the north boundary of lot 686; thence south 335 feet more or less; thence northeast 20 feet more or less along the south boundary of lot 594; thence south along the west right-of-way of West Shore Drive 50 feet more or less; thence southwest 20 feet more or less, thence south 30 feet more or less, thence east 20 feet more or less around the southwestern perimeter of lot 594; thence east to the point of beginning.

A nominee for director to be qualified to fill any of these vacancies must be a freeholder in their Area or an officer or nominee of a corporate freeholder in their Area and must be qualified by knowledge and experience in matters pertaining to the development of the South-West Lake Maxinkuckee Conservancy District.

Nominations for director must be signed by at least 5 freeholders from their Area and be submitted to the District at P.O. Box 56, Culver IN 46511 (delivered or postmarked) before December 1, 2024, all in accordance with Indiana state statute IAC 14-33.5-3.
