SOUTH-WEST LAKE MAXINKUCKEE CONSERVANCY DISTRICT RESOLUTION CONCERNING SUBMISSION OF DRAWINGS, SPECIFICATIONS AND COST ESTIMATES TO THE NATURAL RESOURCES COMMISSION FOR APPROVAL OF THE WORK TO IMPLEMENT THE DISTRICT PLAN
